

Autonym Pte. Ltd ("Autonym", "we," "our," or "us") is a enterprise content services software developer and publisher committed to helping employers and employees protecting the privacy of their corporate communications, providing user-centric encryption for enterprise data sharing and storage, digital signature and workspaces. This Privacy Policy explains how your personal information may be collected, used, and disclosed by Autonym. This Privacy Policy applies to our website and associated subdomains (our "Services") including our web application called Nevermind Enterprise Data Encryption available at https://app.nvmcifer.com By accessing or using our Service, you signify that you have read, understood, and agree to the limited collection, storage, use, and disclosure of your personal information as described in this Privacy Policy and our Terms of Service.

Definitions and key terms

To help explain things as clearly as possible in this Privacy Policy, every time any of these terms are referenced, are strictly defined as:

- Cookie: small amount of data generated by a website and saved by your web browser. It is used to identify your browser, provide analytics, remember information about you such as your language preference or login information.
- Company: when this policy mentions "Company," "we," "us," or "our," it refers to Autonym Pte. Ltd that is responsible for your information under this Privacy Policy.
- Country: where the customer is based.
- Customer: refers to the company, organization or person that signs up to use our Services to manage the relationship with you, your consumers or services users.
- Device: any internet connected device such as a phone, tablet, computer or any other device that can be used to visit our website https://nvmcifer.com and use our app services https://app.nvmcifer.com
- IP address: Every device connected to the Internet is assigned a number known as an Internet protocol (IP) address.

These numbers are usually assigned in geographic blocks. An IP address can often be used to identify the location from which a device is connecting to the Internet.

- Personnel: refers to those individuals who are employed by Autonym or are under contract to perform a service on behalf of one of the parties.
- Personal Data: any information that directly, indirectly, or in connection with other information including a personal identification number allows for the identification or identifiability of a natural person.
- Services: refers to the services provided by Autonym as described in the Nevermind App's Terms of Service located at https://nvmcifer.com/downloads/Terms of Use en.pdf (and any successor or related locations designated by us), as it may be updated by us from time to time.
- Third-party service: refers to advertisers, contest sponsors, promotional and marketing partners, and others who provide our content or whose products or services we think may interest you.
- Website: Nevermind website can be accessed via this URL: https://nvmcifer.com
- You: a person or entity that is registered with Nevermind to use the Services.

Information automatically collected

There is some information like your Internet Protocol (IP) address and/or browser and device characteristics — could be collected automatically when you visit our platform. This information may be used to connect your computer to the Internet. Other information collected automatically could be a login, e-mail address, password, computer and connection information such as browser plug-in types and versions and time zone setting, operating systems and platforms, purchase history, (we sometimes aggregate with similar information from other Users), the full Uniform Resource Locator (URL) clickstream to, through and from our Website that may include date and time; cookie number; parts of the site you viewed or searched for; and the phone number you used to call our Customer Services. We may also use browser data such as cookies, Flash cookies (also known as Flash Local Shared Objects) or similar data on certain parts of our website for fraud prevention and other purposes. During your visits, we may use software tools such as JavaScript to measure and collect session information including page response times, download errors, length of visits to certain pages, page interaction information (such as scrolling, clicks, and mouse-overs), and methods used to browse away

from the page. We may also collect technical information to help us identify your device for fraud prevention and diagnostic purposes.

We usually only collect very basic information when you visit, use or navigate the platform. This information does not reveal your specific identity (like your name or contact information) but may include device and usage information, such as your IP address, browser and device characteristics, operating system, language preferences, referring URLs, device name, country, location, information about who and when you use our and other technical information. This information is primarily needed to maintain the security and operation of our platform, and for our internal analytics purposes.

Personnel

If you are an Autonym worker or applicant, we collect information you voluntarily provide to us. We use the information collected for Human Resources purposes in order to administer benefits to workers and screen applicants.

You may contact us in order to (1) update or correct your information, (2) change your preferences with respect to communications and other information you receive from us, or (3) receive a record of the information we have relating to you. Such updates, corrections, changes and deletions will have no effect on other information that we maintain, or information that we have provided to third parties in accordance with this Privacy Policy prior to such update, correction, change or deletion.

Sale of Business

We reserve the right to transfer information to a third party in the event of a sale, merger or other transfer of all or substantially all of the assets of Autonym or any of its Corporate Affiliates (as defined herein), or that portion of Autonym or any of its Corporate Affiliates to which the Service relates, or in the event that we discontinue our business or file a petition or have filed against us a petition in bankruptcy, reorganization or similar proceeding, provided that the third party agrees to adhere to the terms of this Privacy Policy.

Affiliates

We may disclose information (including personal information) about you to our Corporate Affiliates. For purposes of this Privacy Policy, "Corporate Affiliate" means any person or entity which directly or indirectly controls, is controlled by or is under common control with Autonym, whether by ownership

or otherwise. Any information relating to you that we provide to our Corporate Affiliates will be treated by those Corporate Affiliates in accordance with the terms of this Privacy Policy.

Governing Law

This Privacy Policy is governed by Singapore law without regard to its conflict of laws provision. You consent to the exclusive jurisdiction of the courts of Singapore in connection with any action or dispute arising between the parties under or in connection with this Privacy Policy.

The law of Singapore, excluding its conflicts of law rules, shall govern this Agreement and your use of our website. Your use of our web app and website may be subject to other local, state, national, or international laws.

By using Autonym or contacting us directly, you signify your acceptance of this Privacy Policy. If you do not agree to this Privacy Policy, you should not engage with our website, or use our app services. Continued use of the website and/or app, direct engagement with us, or following the posting of changes to this Privacy Policy that do not significantly affect the use or disclosure of your personal information will mean that you accept those changes.

Your Consent

We have updated our Privacy Policy to provide you with complete transparency into what is being set when you visit our site and how it's being used. By using our website, registering an account, or making a purchase, you hereby consent to our Privacy Policy and agree to its terms.

Links to Other Websites

Third parties may use their own cookies or other methods to collect information about you.

Cookies

Autonym may use "Cookies" to identify the areas of our website that you have visited. A Cookie is a small piece of data stored on your computer or mobile device by your web browser. We may use Cookies to enhance the performance and functionality of our website but are non-essential to their use. However, without these cookies, certain functionality like videos may become unavailable or you would be required to enter your login details every time you visit the website as we would not be able to remember that you had logged in previously. Most web browsers can be set to disable the use of Cookies. However, if you disable Cookies, you may not be able to access functionality on our website correctly or at all. We never place Personally Identifiable Information in Cookies.

Blocking and disabling cookies and similar technologies

Wherever you are located you may also set your browser to block cookies and similar technologies, but this action may block our essential cookies and prevent our website from functioning properly, and you may not be able to fully utilize all of its features. You should also be aware that you may also lose some saved information (e.g. saved login details, site preferences) if you block cookies on your browser. Different browsers make different controls available to you. Kids' Privacy

Information about General Data Protection Regulation (GDPR)

We may be collecting and using information from you if you are from the European Economic Area (EEA), and in this section of our Privacy Policy we are going to explain exactly how and why this data is collected, and how we maintain this data under protection from being replicated or used in the wrong way.

What is GDPR? GDPR is an EU-wide privacy and data protection law that regulates how EU residents' data is protected by companies and enhances the control the EU residents have over their personal data. The GDPR is relevant to any globally operating company and not just the EU-based businesses and EU residents. Our customers' data is important irrespective of where they are located, which is why we have implemented GDPR controls as our baseline standard for all our operations worldwide.

What is personal data? Any data that relates to an identifiable or identified individual. GDPR covers a broad spectrum of information that could be used on its own, or in combination with other pieces of information, to identify a person.

Personal data extends beyond a person's name or email address. Some examples include financial information, political opinions, genetic data, biometric data, IP addresses, physical address, sexual orientation, and ethnicity.

The Data Protection Principles include requirements such as:

- Personal data collected must be processed in a fair, legal, and transparent way and should only be used in a way that a person would reasonably expect.
- Personal data should only be collected to fulfil a specific purpose and it should only be used for that purpose. Organizations must specify why they need the personal data when they collect it.
- Personal data should be held no longer than necessary to fulfil its purpose.
- People covered by the GDPR have the right to access their own personal data. They can also request a copy of their data, and that their data be updated, deleted, restricted, or moved to another organization.

Why is GDPR important? GDPR adds some new requirements regarding how companies should protect individuals' personal data that they collect and process. It also raises the stakes for compliance by increasing enforcement and imposing greater fines for breach. Beyond these facts it is simply the right thing to do. At Autonym, we strongly believe that your data privacy is very important, and we already have solid security and privacy practices in place that go beyond the requirements of this new regulation.

Individual Data Subject's Rights - Data Access, Portability and Deletion

We are committed to helping our customers meet the data subject rights requirements of GDPR. Autonym processes or stores all personal data in fully vetted, DPA compliant vendors.

On our app, we store only your 8 last selfies in an AWS S3 collection bucket (private) that are used for matchmaking when you login again and validate your authentication, and your last selfie is also used as your profile picture, to guarantee to your contacts that it is you and not someone else. With normal use, your 8 selfies will be stored for a maximum of 8 days. After 8 days of usage all selfies are being replaced by 8 new ones since one selfie is taken per day which replaces the oldest one. If you are not using the app daily, the storage of your selfies may be longer and we will contact you to understand your needs if you have reached the legal limit of 60 days. If you decide to delete your account, we will discard almost immediately all your data in accordance with our Terms of Service and Privacy Policy, and we will not hold any of them.

If you are EU customers, we understand that you need to have the ability to access, update, retrieve and remove personal data if any. We got you! Our customer support team is here for you to answer any questions you might have about working with the app.
